General Terms and Conditions

Definition

K.I.T. Group GmbH Dresden (hereafter referred to as K.I.T. Group Dresden) is the registration office of the 4th Resolution Days (hereafter referred to as RD 2025), which takes place from April 8-10th, 2025 in Frankfurt/Main, Germany. K.I.T. Group Dresden is authorized to act on behalf of the conference host. K.I.T. Group Dresden is responsible for the registration. These General Terms and Conditions are valid for each registered attendee of RD 2025. Any person registered is considered an attendee.

The conference host reserves the right to change the conference format to hybrid or to purely virtual if external circumstances make it necessary.

Registration

The registration and payment deadlines are as follows:

Early registration deadline: **December 15th, 2024, 23:59:59 CET,**

Standard registration: from **December 16th, 2024, 00:00:00 CET**

Everyone who wants to attend the conference must register. Until the standard registration deadline, the registration to the conference is solely possible via the online registration form. With the completion of the online registration (by clicking the button "Bindingly register" or "Pay" at the end of the form) the contract between K.I.T. Group Dresden and the participant is legally binding. K.I.T. Group Dresden is authorized to act on behalf of the Conference Host.

Everyone who wants to register at a reduced registration fee (e. g. students, Early Career Researchers, etc.) needs to provide the requested proof to K.I.T. Group Dresden upon registration.

The participant will receive an official confirmation of registration and invoice from K.I.T. Group Dresden via email. All registration fees must be paid in due time according to the due date stated on the invoice. For applying for the early/regular registration fee, payment in full must be made within the given deadlines. Early registration discount is offered until December 15th, 2024. To be considered as early registration payment has to arrive latest December 20th, 2024. Otherwise, the registration secretariat reserves the right to change the registration to the higher registration fee and send a new invoice.

Payments are only accepted in EUR and can be made by credit card or by bank transfer. Any bank charges must be paid by the participant. Cheques will not be accepted. All registration fees must be fully paid prior to the conference. If the payment is still outstanding at the first conference day, payment may be made on-site at the registration desk by credit card or in cash. Only after full payment has been received, the registration will be considered valid.

Visa requirements and invitation letter

It is the sole responsibility of the attendee to take care of her/his visa requirements. Attendees who require an entry visa must schedule sufficient time for the application procedure. Attendees should contact the nearest embassy or consulate to determine the appropriate timing of their visa applications. It is recommended to apply for a visa at least three months in advance of the conference.

Everyone who requires an official letter of invitation can request it via email. Invitation letters will be issued only for registered delegates, who fully paid their registration fee. Invitation letters will be issued electronically (as PDF file via email). Upon request, a hand-signed hard copy can be sent via regular mail service. Kindly note that tracking of regular mail is not possible and that mail delivery times are beyond the organizers control. Express delivery is possible upon request as well but will involve an extra service charge. Issuing the invitation letter does not financially obligate the conference host/ registration secretariat in any way. All expenses incurred in relation to the conference are the sole responsibility of the attendee.

Cancellation policy

All registration changes and cancellations must be communicated to K.I.T. Group Dresden in written form by email or mail. In case of cancellation of registration or cancellation of single bookings received **on or after March 1st, 2025**, a cancellation fee of 65% of the participation fee (for category: "registration without accommodation") or 50% of the participation fee (for category: "registration with accommodation") will be charged. No refund will be given for any cancellations made after **April 1st, 2025**, and the claim for the full payment of all registration fees remains, respectively.

In case of cancellations due to denied VISA applications, the full registration fee minus a processing fee of EUR 50.00 will be refunded after the conference if the visa was applied for in time. To apply for the refund, a proof of timely application together with an official notice from the embassy confirming that a visa could not be granted needs to be forwarded to K.I.T. Group Dresden by email or mail.

No refunds will be made for no-shows or early departures, even in cases of illness or force majeure on the part of the participant. Cancellations and booking changes are only accepted in writing. The date of receipt of the written cancellation/change of booking by K.I.T. Group Dresden shall be deemed the date of cancellation.
