



## GENERAL TERMS AND CONDITIONS

### Definition

K.I.T. Group France Association & Conference Management is the PCO – Professional Congress Organiser (hereinafter named K.I.T. Group France) of the **7th International Conference CBRNe Research & Innovation**, to be held in **Arcachon, France, from 19 to 21 May 2026**. The organising committee has appointed K.I.T. Group France to manage the registration and accommodation services for this event.

### General Terms and Conditions for Registration

These terms and conditions apply to all individuals registering for the **CBRNe Research & Innovation 2026 Conference** (hereinafter referred to as “the Congress”), including but not limited to professionals from academia, industry, institutions, emergency services, and the defence & security sector.

### Registration Deadlines

**Early Bird Fee:** until 02 April 2026

Onsite registration won't be available during the Congress.

### Registration Policy

Only fully completed registration forms will be accepted. The registration fee applicable is determined by the date of receipt of the registration and full payment. Registration is only confirmed once full payment has been received.

### Admission Policy and Registration Approval

The organiser reserves the right to approve or reject a registration without justification. If a paid registration is declined, a full refund will be issued. No other claims will be considered.

### Group Registration

Registrations for more than ten (10) participants will be treated as group bookings. Please contact the Congress Secretariat at:

The Secretariat will not be liable for any double registrations submitted by another organisation or company. Once the group registration form is submitted, a payment order will be issued. Full payment is required before final confirmation, and the names of each group participant must be



submitted by 28 April 2026. Name changes are accepted free of charge until that date. No refund will be granted for unused registrations.

### Methods of Payment

Payments must be made in EUR using one of the following methods:

- Credit card (Visa, Mastercard)
- Bank transfer (available until 28 April 2026)

### Confirmation / Payment Receipt

A confirmation email and payment receipt will be sent once the completed registration form and payment are received by the Congress Secretariat.

### Letter of Invitation

To request an official letter of invitation for visa purposes, participants must be registered and have paid in full. No letters will be issued after 28 April 2026.

Such letters do not constitute a commitment from the organiser to provide any financial or logistical support. Visa arrangements are the sole responsibility of the participant.

### Visa Requirements

Participants are solely responsible for verifying and complying with entry and visa requirements for France. The organiser cannot intervene in the visa process.

Refunds will be processed to the original payer only. Name changes are not allowed.

- Until 2 April 2026: €50 administration fee will be retained
- From 2 April to 28 April 2026: 50% of the registration fee will be retained
- After 28 April 2026: No refunds will be issued
