General Terms and Conditions (GTC) - REGISTRATION

Event name: 7th Medicinal Cannabis Congress 2026

Organizer: KIT Group GmbH

Preliminary remarks*

KIT Group GmbH ("KIT Group" or "Organizer") is the organizer of the 7th Medicinal Cannabis Congress 2026, which will take place from May 28-29, 2026, in Berlin ("MCC2026" or "Congress" or "Event").

The organizer manages the congress secretariat and is responsible for the organization and implementation of the event (e.g. registration, hotel accommodation, sponsorship opportunities, exhibition management, etc.).

*For the sake of readability, these General Terms and Conditions refrain from using gender-specific language. Where personal designations are used only in the masculine form, they expressly refer to all genders equally.

Scope

These General Terms and Conditions ("GTC") apply to all conference registrations and are valid for every participant registered for the conference. Each registered individual is considered a participant. These terms and conditions also apply to all group registrations.

Registration for the congress

The registration deadlines are as follows:

Registration deadline Standard fee:	until 26.03.2026, 24:00 CET
Registration deadline Late fee:	March 27 to May 27, 2026, 12:00 midnight CET
Registration on site at the venue:	May 28, 2026, and May 29, 2026

Only fully completed registration forms will be accepted. The registration fee is based on the date of receipt of the registration form or completed online registration, as well as full payment according to the deadlines stated above. Online registration can be completed by clicking the "Register and Pay" button at the bottom of the form. If a deadline is missed, the next fee will be automatically charged. Registration will only be confirmed after full payment has been received.

If the maximum capacity is reached, the organizer reserves the right to reject registrations. In this case, any right to participate is excluded. Access to the conference is only possible for registered participants. The minimum age for registration is 18 years. Each participant may be asked to present an official ID card proving their age.

The applicable registration fees can be viewed on the official website at <https://medicinal-cannabis-congress.org/registrierung/>.

The registration fee for full registration for regular participation includes access to the venue, all sessions, the exhibition area and the poster area (if available).

The registration fee for the day ticket entitles you to attend the congress and includes access to the venue, all sessions, the exhibition area and the poster area (if available) on that day.

Every member of the German Medical Cannabis Society (Deutsche Medicinal Cannabis Gesellschaft eV) with a balanced membership account is entitled to register at the published member rates. Registration for preferential member rates is only possible upon providing the membership number.

Participants at the student rate must present and/or carry proof of full-time enrollment at a recognized university or college (valid student ID or official letter from the university) both at registration and during the conference.

Media registration

To register as a media representative, you must submit your official press pass to the organizer at mcc@kit-group.org. There is no registration fee for accredited media representatives.

Group registration

Group registrations will be accepted with a minimum of 10 participants. Further information can be obtained from the organizer at mcc@kit-group.org. If the prepaid amount is not fully used during pre-registration, the remaining amount can be used for on-site registration. No refunds will be issued for badges paid for but not used (according to the above-mentioned deadlines). The **deadline for group registrations is May 22, 2026**. After the group registration deadline, registrations will only be accepted on-site. Only fully completed online group registration forms (including the full names, individual email addresses, and postal addresses of the participants) will be accepted. The organizer cannot be held responsible for duplicate bookings of an individual participant or group made by another company or organization.

Payment methods

Payment must be made in full at the time of registration and in EUR using one of the following payment methods:

1. Credit card

Payment via Visa, AMEX or MasterCard: credit cards will be charged in EUR.

All transfer fees are the responsibility of the participant and must be paid in advance. Checks are not accepted.

Confirmation letter/receipt of payment

Once the organizer has received the fully completed registration form and the corresponding payment, a confirmation letter/invoice will be sent by email.

Invitation letter

If an official invitation letter is required, it must be requested from the organizer. This is only possible if the participant has registered for the conference and has received full payment. The invitation letter does not create any financial obligation on the part of the organizer. All costs incurred in connection with the conference are the sole responsibility of the participant.

Visa requirements

Participants are responsible for complying with applicable visa and entry regulations. If an entry visa is required, participants must allow sufficient time for the application process. Each affected participant is required to apply for a visa at least three months before the conference. If a timely application for a visa is rejected or issued late, and the registration fee has already been paid, the fee will be refunded, less a processing fee of EUR 55, no later than 90 days after the conference. Participants are required to provide the relevant documentation to the organizer at mcc@kit-group.org (at least a copy of the application and the rejection notice; proof of delivery in the case of a delayed application).

Certificate of participation

Each participant who attended the in-person event will receive a certificate of participation electronically after the conference to the email address provided during registration. Certificates of participation cannot be issued on-site, and any claim to this is excluded.

Registration: Withdrawal from registration and cancellation rules

Participation in the conference can be canceled with a refund of the paid participation fee. **Cancellations must be submitted in writing to the organizer by email at mcc@kit-group.org by March 13, 2026 (date of receipt)** . Refunds will be made exclusively via the payment method selected upon registration. Refunds to a different payment method, a different payee, or to third parties are excluded. The processing fee for refunds is EUR 55 including VAT and will be deducted from the refund amount.

If registration is cancelled after **14.03.2026** A cancellation fee equal to the full registration fee will be charged; in these cases, no refunds are possible.

Refund requests are generally processed within 90 days of the end of the conference.

In the event of an event not attended or premature termination of participation, no refund will be given.

Change from face-to-face event to virtual event

Should the congress not be able to be held on-site on the agreed dates due to events beyond the control of the organizer or due to events that are not attributable to the organizer's willful intent or gross negligence, and the organizer decides to convert the congress into a purely virtual event, the organizer cannot be held liable by the participants for any damages or costs incurred, nor for any losses, such as transport costs, accommodation costs or other losses.

If the congress is converted into a virtual event, all participants who have completed their registration will automatically remain registered for the virtual event, and the organizer will refund, if applicable, the difference in payment between the registration fees for the in-person event and the virtual event.

In the event of a decline in virtual participation in the congress, any participant may notify the organizer of their withdrawal from the virtual congress in writing to mcc@kit-group.org **within 14 days of receiving notification of the changeover and/or publication of the decision on the congress website** . The date of receipt of the declaration by the organizer is decisive for compliance with the deadline. In these cases, the participant will receive a refund of the registration fee, subject to a processing fee of EUR 55 including VAT per registration. Otherwise, the provisions of the above section "*Registration: Withdrawal from Registration and Cancellation Rules*" apply.

Registration name change

A processing fee of EUR 55.00 including VAT will be charged for a name change to an existing registration or, in the event of withdrawal, for the naming of a substitute. In addition to the new registration form, appropriate proof of eligibility for the substitute will be required if the reduced registration fee is applied. Without appropriate proof, discounts cannot be considered, and the

registration fee valid at the time of booking will be charged. Name changes or the naming of substitutes can only be made up to the registration deadline of May 27, 2026, and must be fully completed, providing all participant details are provided.

Lost name tags

The issued official name badge must be worn by each participant throughout the entire conference. Access to the conference facilities will not be provided without a proper, valid name badge. If a participant loses, misplaces, or forgets their name badge, a processing fee of €55 will be charged for a new name badge. Upon receipt of a new name badge, the lost name badge automatically becomes invalid.

Stay

Only registered or sign-up participants are permitted to attend the event. Children and young people under the age of 18 are generally not permitted to attend. Seating in the meeting rooms is limited. Refunds due to full occupancy are not possible.

Change to the congress program

The conference program is published as a guide only and is subject to change at any time in terms of timing, location, themes, and content (particularly regarding the program schedule, the nomination and/or selection of speakers, the technical environment, the program duration, etc.). Program changes do not constitute a right of withdrawal or reimbursement for registered participants, provided that the nature of the event as a professional event in the specified subject area is not compromised by the changes.

Cancellation of the congress; force majeure; hardship

If the congress cannot take place or is postponed, or if the organizer is prevented from fulfilling its obligations in connection with the congress due to external, unforeseeable events for which it is not responsible ("force majeure") through no fault of its own, or if circumstances arise that were unforeseeable and, had the organizer been aware of them, would not have concluded this contract under these terms and conditions, and whose remediation is not possible using commercially reasonable means ("hardship"), the organizer has the right to cancel the congress immediately upon becoming aware of the aforementioned circumstances and/or to terminate the congress without any liability. In these cases, the organizer is released from its obligations to the participants and cannot be held liable by the participants for damages, costs, or losses such as transport costs, accommodation costs, financial losses, lost profits, etc. The organizer reserves the right either to retain the entire registration fee and use it for a future or postponed congress or to reimburse the participant an amount, pro rata to the costs already incurred for the organization of the congress that could not be reclaimed from third parties.

Hygiene and safety regulations; house rules

Before attending the congress, each participant is obliged to inform themselves about the currently valid regulations regarding mandatory health and hygiene measures or safety concepts issued by the state or by the organizer or third parties and to comply with them.

The organizer reserves the right to adapt relevant measures and concepts to the current legal situation at any time. Each participant is obligated to keep themselves informed of any changes and adjustments.

By entering the venue, each participant accepts the venue's house rules, which are available for review at the registration desk. Each participant acknowledges that the consumption of food and beverages brought outside is not permitted in the venue.

Data protection and sharing of personal data

During the registration process and the conduct of the congress, the personal data of each participant will be processed. All personal data will be processed in compliance with applicable national data protection regulations, in particular the General Data Protection Regulation (GDPR) (Regulation (EU) 2016/679) and the German Federal Data Protection Act (BDSG).

Personal data will not be passed on to third parties unless there is a legal basis pursuant to Art. 6 (1) (a) GDPR: (a) explicit consent, (b) performance or conclusion of a contract, (c) compliance with a legal obligation, (d) protection of vital interests of the data subject or of another natural person, (e) public interest or exercise of official authority, (f) legitimate interest of the controller and balance of interests.

As part of your participation in the congress, personal data may be processed by companies based in third countries without an adequacy decision from the EU Commission. Participants consent to this data processing to the extent necessary for their participation and the full use of the congress services, while acknowledging that the assertion of data protection rights and the right to lodge complaints may be limited or made more difficult.

Further details on data processing, the data subject's rights to information, objection, revocation of consent, blocking and deletion of personal data, as well as information about personal data and how to contact the data protection officer are available in the [data protection provisions](#).

Intellectual property rights

All content (trademarks, brands, copyrights, etc.) displayed at and/or during the congress remains the property of their respective owners and is used for identification purposes only. The content and compilations published on the event website and/or associated websites are subject to applicable copyright laws. Reproduction, processing, distribution, forwarding, and/or any type of exploitation outside the limits of applicable copyright law require the written consent of the respective author or creator.

Downloads and copies of information, documents, files, presentations, and other shared content are permitted only if expressly marked otherwise and solely for private use. Commercial use of content is prohibited without the consent of the author/creator. To the extent that the content on the event platform and/or website was not created by the organizer, the copyrights of third parties are respected. Contributions by third parties are marked as such on the event platform website. Should a copyright infringement nevertheless occur, the organizer requests appropriate notification. The content in question will then be removed immediately.

Respect for copyright

The participant confirms that any congress-related use or exploitation of works and/or materials used by him in connection with an activity or on the occasion of participation in such an activity (i.e. lecture, presentation, moderation and/or other contributions, etc.) is lawful and, in particular, in compliance with all applicable copyright protection regulations and in recognition of all third-party rights.

The participant further acknowledges that the above warranty extends to the documentation of the event and its public reporting through means such as photography, filming, and recording as described above. The participant/presenter indemnifies the organizer from all claims, liabilities, losses, or costs (including legal fees, to the extent permitted by law) arising from a breach of the above warranty.

The congress website and its use

Unless expressly stated otherwise or apparent from the circumstances, all content presented on the congress website is the property of the organizer. Each participant with a completed and confirmed registration is entitled to view any part of the congress website and to copy or download content, provided this is done solely for personal or non-commercial use and does not infringe the rights of third parties. Any other reproduction of the content of the congress website requires the approval of the organizer in all cases.

Viruses or other technical malfunctions; blocking of access; exclusion of warranty

Every reasonable effort is made to ensure that downloadable content is free of viruses. The organizer assumes no liability for damage caused by viruses transmitted from this website and/or any digital event

platform to third-party computer systems. The organizer cannot guarantee uninterrupted use of the conference website and/or any digital event platform. Claims for damages in this regard are excluded.

Access to the conference website, the associated digital offerings, and/or a digital event platform may be temporarily or permanently blocked if there are concrete indications that the participant is violating or has violated these Terms and Conditions and/or applicable law, or if the organizer has another legitimate, substantial interest in blocking access. The legitimate interests of the participant will be appropriately considered when deciding on a blocking.

The organizer provides no guarantee for the adequacy, accuracy, and/or completeness of the information published in connection with the congress. Furthermore, the organizer does not guarantee uninterrupted and/or error-free access to the congress websites. The organizer will endeavor to resolve such interruptions as quickly as possible using commercially reasonable means. Otherwise, the regulations regarding connectivity and technical issues apply.

Film, photo and video recordings

The participant is informed and consents to the fact that the organizer may make images, film, and sound recordings for educational purposes during the congress. This material may be shared and published as part of public reporting or used on social networks about the event without entitlement to compensation. The participant expressly consents to the use of relevant images, voices, and other content recorded during the event for publications and communications related to the event, within the framework of applicable law. The participant waives any right to compensation and will not assert any claims to compensation. Any participant may revoke their consent at any time by sending an email to the organizer at mcc@kit-group.org. revoke.

Limitation of liability

The organizer is liable for intent and gross negligence.

The organizer is only liable for simple negligence in the event of a breach of an obligation whose compliance is essential for the proper performance of the contract and on whose proper fulfillment the contractual partner may regularly rely (so-called "cardinal obligations"). Otherwise, the organizer is not liable for damages of any kind, regardless of the legal basis, including pre-contractual liability.

If the organizer is liable for simple negligence in the sense, liability is limited to such damages whose occurrence could reasonably be foreseen based on the circumstances known at the time of registration.

The aforementioned exclusions of liability do not apply to damage resulting from injury to life, body, or health. Liability under the Product Liability Act remains unaffected.

The above exclusions of liability also apply to employees, agents and other third parties commissioned by the organizer to carry out the registration contract.

Place of performance and jurisdiction

The place of performance is Berlin. The exclusive place of jurisdiction for disputes with merchants, legal entities under public law, or special funds under public law arising from contracts is also Berlin.

All disputes relating to participation in the event, regardless of their legal basis, shall be governed exclusively by the laws of the Federal Republic of Germany, excluding all conflict of law provisions that refer to another legal system. The application of the UN Convention on Contracts for the International Sale of Goods is excluded.

Subject to change

The organizer may make changes and/or additions to these General Terms and Conditions at any time. Participants will be informed of such changes from time to time. If the changes and/or additions affect essential parts of the participation contract and significantly alter the participant's rights, each participant with an existing and paid registration will be informed separately and given the opportunity to consent.
