GENERAL TERMS AND CONDITIONS

Definitions

K.I.T. Group GmbH is the official housing agency of ESSKA 2026, the 22nd ESSKA Congress (ESSKA2026) to be held in Prague, Czech Republic, from 20 to 22 May 2026 at the O_2 Universum Prague. ESSKA is a non-profit, scientific organisation (hereinafter "organiser"). The housing agency leads the hotel accommodation and is hereinafter referred to as "K.I.T. Group".

Terms and Conditions for Hotel Bookings Reservation

Hotel accommodation is subject to availability and will be allocated on a first come, first served basis.

All rates listed are in Euro (EUR) and show the room rate per night, including breakfast and all applicable taxes.

All rates are subject to change. In case of a VAT increase or an introduction of a city tax for business travel, the room rates will be changed accordingly.

Telephone reservations will not be accepted. All reservations must be made using the official booking form and submitted with full credit card details, without which the booking cannot be processed. The option to pay by bank transfer may be available at the time of booking and no credit card details would be necessary. Nevertheless, the booking can be confirmed only after the full payment is received.

Should the selected hotels be sold out, K.I.T. Group reserves the right to book a hotel in a similar category and price range. The check-in and check-out times of the respective booked hotel partner apply. Should you plan to arrive at your hotel after 18.00 please inform K.I.T. Group accordingly.

Please contact K.I.T. Group at <u>esska-hotels@kit-group.org</u> for bookings of 10 rooms or more, as they will be handled separately.

Payment

Accommodation will be allocated upon receipt of the hotel booking request, together with the credit card details. When using a credit card, K.I.T. Group will charge the full balance due for the entire stay at the time of room reservation. K.I.T. Group will then send a booking confirmation. Invoices will be sent automatically after the conference.

A 3.5~% convenience fee will be automatically added to the accommodation amount due. This convenience fee will not show on the accommodation invoice. A payment receipt will be sent to each delegate upon request.

Alternatively, a bank transfer for the entire amount (free of bank fees) can be made within 7 working days of the booking being made or by 6 January 2026 (whichever is earlier) or the booking request will automatically be cancelled. Once the full payment is received, K.I.T. Group will send out a booking confirmation. The invoices will be sent automatically after the conference.

From 6 January 2026, only credit card payments will be accepted, and the provided credit card will be debited upon receipt of the booking with the full balance due.

Should K.I.T. Group not receive the payment on time or not be able to debit the provided credit card on 6 January 2026, the hotel reservation will be cancelled in accordance with the cancellation conditions.

Confirmation and Invoice

Confirmation of the hotel booking will be sent out upon receipt of the housing request and full credit card details or payment of the full accommodation value by bank transfer. The accommodation invoice will be sent out automatically to each delegate after the conference.

Changes and Cancellations

All changes and cancellations must be sent in writing by email to <u>esska-hotels@kit-group.org</u>. Please note that hotels will not accept any changes or cancellations directly.

- For cancellations received before 6 January 2026, a non-refundable admin fee of 35,00 EUR will be retained by K.I.T. Group.
- Cancellations received after 6 January 2026 will not be eligible for a refund. After this date, in the
 case of existing or new bookings, the full amount of the reservation value indicated on the hotel
 reservation form will be charged.
- This does also apply for a reduction in the length of stay if notified after 6 January 2026.
- No-shows will be released automatically by the hotel at 09:00 on the morning of the day following the booked and confirmed arrival date and the accommodation fee will not be refunded.

Cancellation of the Conference due to Force Majeure

In the event that the conference cannot be held or is postponed due to events beyond the control of the organiser and K.I.T. Group (force majeure) or due to events which are not attributable to wrongful intent or gross negligence of the organiser and/or K.I.T. Group, neither the organiser nor K.I.T. Group can be held liable by guests for any damages, costs, or losses incurred, such as transportation costs, accommodation costs, financial losses, etc.

Refund Policy

Payments already made with K.I.T. Group for ESSKA 2026 can only be refunded under the mandatory condition that K.I.T. Group has received the full refund of all advance payments, deposits and/or other payments previously made in execution of this contract back from the hotel. Refunds will only be made after the final invoice has been issued.

Refunds will only be credited to the person/company that paid for the original booking. Refunds will only be made via the payment method used at the time of booking and are excluded to or in favour of third parties.

Regulations of Hotel Partners

Guests are obliged to follow the hygiene regulations of the hotel partner. In compliance with the applicable hygiene regulations, we reserve the right to pass on your contact details to your booked hotel.

Data Protection

During the booking process and the execution of the stay at the chosen hotel accommodation the personal data of each attendee is processed. All personal data will be processed in accordance with the applicable national data protection regulations and in particular the General Data Protection Regulation GDPR (Regulation (EU) 2016/679) and the German Federal Data Protection Act (BDSG).

Personal data will not be forwarded to a third party unless in accordance with Art. 6 Sec. 1 lit a-f GDPR: (a) express consent, (b) performance or conclusion of a contract, (c) fulfilment of a legal obligation, (d) protection of vital interests of the data subject or another natural person, (e) public interest or exercise of official authority, (f) legitimate interest of the data controller and balancing of interests.

Within the scope of service provision, personal data may be processed by companies/hotel partners based in third countries outside the European Union (EU)/European Economic Area (EEA). This can lead to disadvantages in the enforcement of data subjects' rights, a lack of control over the further processing and transfer of data or access by state agencies for control and monitoring purposes without sufficient

legal protection. By registering for the Congress the attendee consents to such data processing insofar as it is necessary for his/her participation and the full use of the Congress services.

Liability

K.I.T. Group shall be held liable in the framework of a duty of care as a respectable businessman according to statutory provisions. The liability of the conference organizer - for whatever legal reason - shall be limited to intent and gross negligence. The liability of commissioned service providers shall remain unaffected by this. The attendee shall take part in the conference at his/her own risk. Oral agreements shall not be binding if these have not been confirmed in writing by the conference organizer.

Fulfilment and Jurisdiction

This contract is subject to the law of Berlin, Germany. The terms of this contract shall be fulfilled in Prague / Czech Republic and in the event of any legal claims arising from either party, Berlin, Germany shall be the sole court of jurisdiction.

Severability Clause

If there is a determination of these Terms and Conditions to be ineffective or impracticable, then the validity of the Terms and Conditions remaining are not impaired. The parties are obligated to cooperate in order to replace the ineffective or impracticable clause by an effective or feasible clause, which results in the ineffective or impracticable clause being closed.
